Regarding Department of Health and Senior Services Licensing Certificate above. Buyer should confirm information with MO DHSS.

Penny- If someone wishes to reopen the facility within one year, they would not have to go through the full Certificate of Need process. They would need to contact CON to request a relicensure letter. The same number of beds could be licensed, as long as the person is not trying to purchase the beds and put them in a different facility. The facility would still be under the same fire safety, physical plant, and construction standards that it was under at the time of closure (as long as it is reopened within one year of July 8). To reopen, the person would have to submit an application to license the facility after obtaining a CON letter. Once we approve the application for licensure, the regional office and fire marshal's office would need to conduct an initial inspection. The facility would open once the facility passes the initial inspections- so the person reopening would have to have it reopened by July 8, 2025 in order to be under the same regulations.

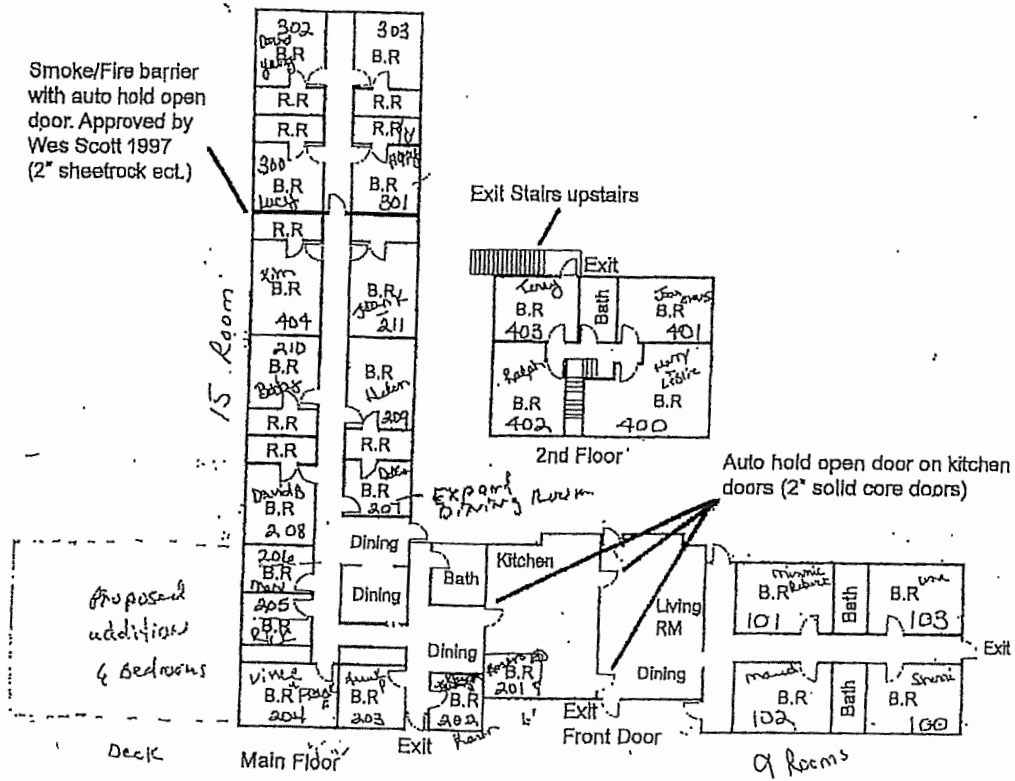

This letter is to confirm the Department of Health and Senior Services, Section for Long Term Care Regulation (SLCR), spoke with Penny Worthley regarding Hillcrest Residential Care, Inc. Ms. Worthley indicated all residents located at Hillcrest Residential Care, Inc, a 33 bed Assisted Living Facility were relocated and the facility closed July 11, 2024.

Therefore, effective July 12, 2024, Hillcrest Residential Care, Inc is no longer a licensed Assisted Living Facility. License #051335 issued to Hillcrest Residential Care, Inc, d/b/a Hillcrest Residential Care, Inc, is null and void.

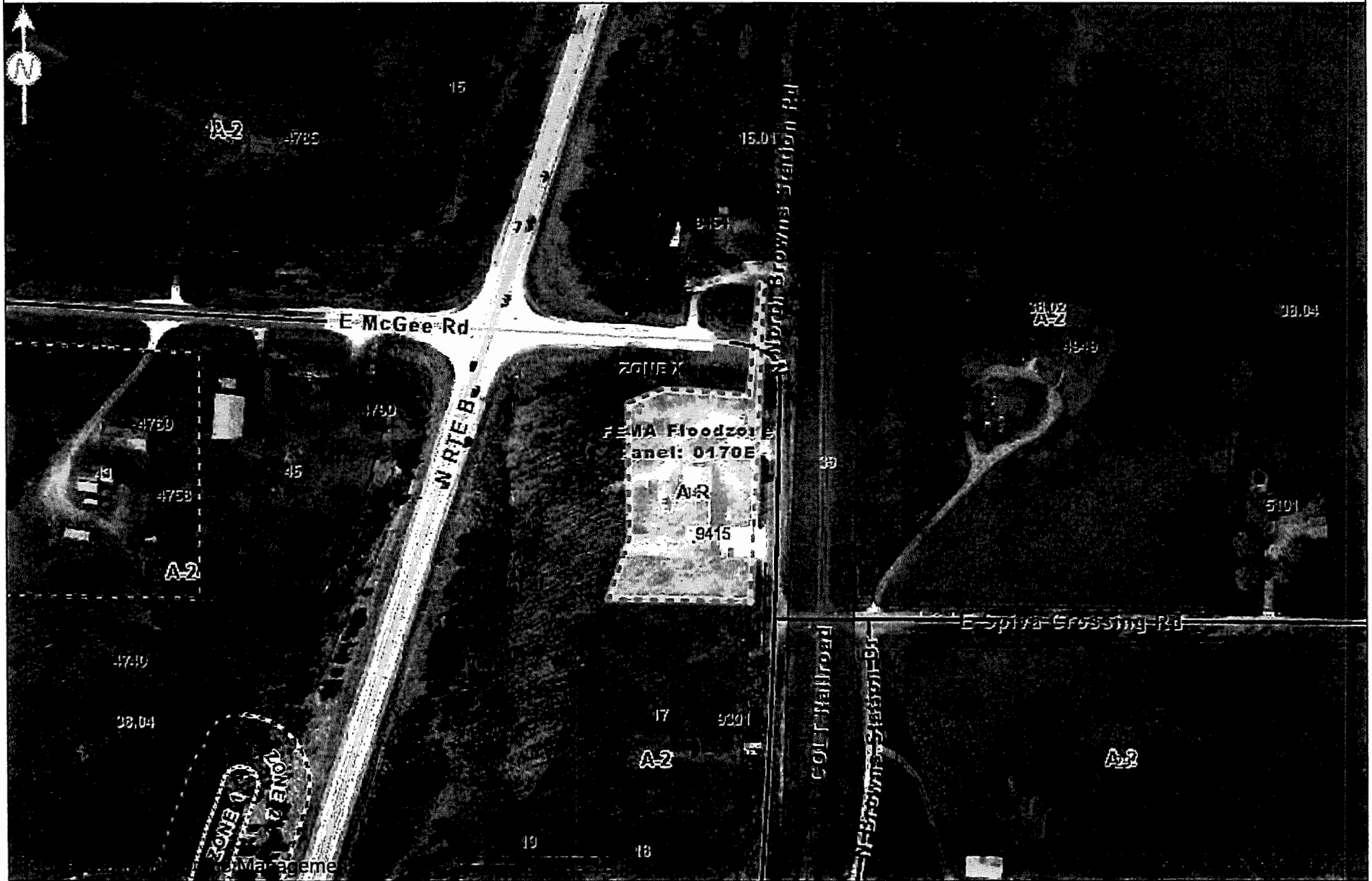
